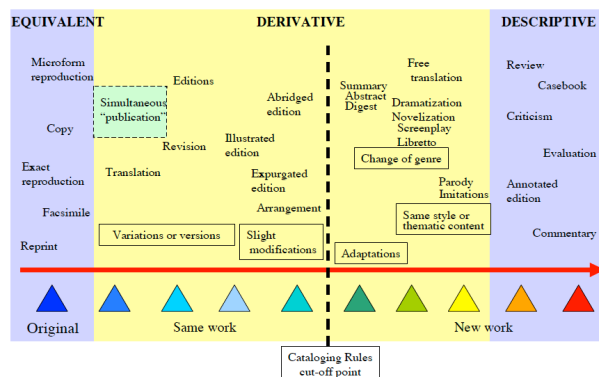
Stockholm Seminar on Cataloguing (1990)

- IFLA-sponsored seminar with participants from around the world
- Agreement on the need for a re-examination of existing international cataloguing practices
- Proposed an IFLA-sponsored study to:
 - Examine the relationships between the data elements in bibliographic records and the user needs to be met.
 - Recommend an internationally acceptable basic level of functionality and a set of basic data requirements for records created by national bibliographic agencies.
- *i.e. what do we really need in our records?*

Toronto Conference (1997)

- International Conference on the Principles and Future development of AACR
- raised a number of issues with the cataloguing code
- some issues had already been addressed in updates to AACR2, For example, the redefinition of *seriality* and introduction of **mode of issuance**

RDA on the Ground | APLA 2013

an examination of the structure of AACR

Tom Delsey's *"The Logical Structure of the Anglo-American Cataloguing Rules"* (1998) identified some problems, for example:

- Chapters per "class of material"
- Focus on "document" implying an item-in-hand
- Published/unpublished vs. online
- Focused on fixed attributes rather than changing attributes common in online resources

a desire to be more international in scope

IME-ICC work

- The new "[Statement of International Cataloguing Principles](#)" (2009)
 - also uses the FRBR model and language
 - update to the Paris Principles (1961)

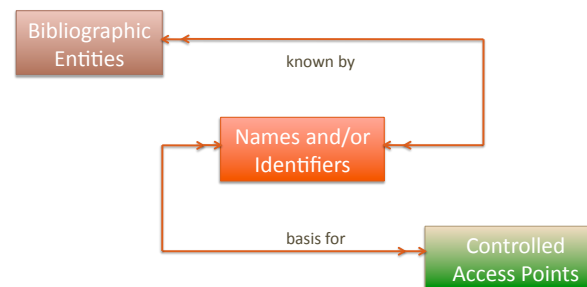
IME-ICC General principles (update to the Paris Principles)

1. convenience of the user
2. common usage
3. representation
4. accuracy
5. sufficiency and necessity
6. significance
7. economy
8. consistency and standardization
9. integration

The rules in a cataloguing code should be *defensible* and *not arbitrary*. It is recognized that these principles may contradict each other in specific situations and a defensible, practical solution should be taken.

FRAD basic relationships

FRAD (continued)

- User tasks:
 - **Find** (e.g. information on an entity and its associated resources)
 - **Identify** (e.g. confirm that the entity described corresponds to the entity sought)
 - **Contextualize** (rda: clarify) (e.g. clarify the relationship between two or more entities, or between an entity and a name it is known by)
 - **Justify** (rda: understand) (e.g. understand why a particular name or title is chosen as the "preferred" name or title)
- Entities:
 - FRBR Group 1 (work, expression, manifestation, item)
 - FRBR Group 2 (person, family, corporate body)

RDA on the Ground | APLA 2013

FRSAD Functional Requirements for Subject Authority Data

- Focuses on FRBR Group 3 entities
 - concept, object, event
- User Tasks (as of final report, June 2010):
 - **Find** (e.g. a subject corresponding to the user's stated criteria)
 - **Identify** (e.g. a subject based on specific attributes or characteristics)
 - **Select** (e.g. a subject appropriate to the user's needs)
 - **Explore** (e.g. relationships among subjects in order to understand the structure of the subject domain)

- IFLA-sponsored seminar with participants from around the world

RDA on the Ground | APLA 2013

user tasks

- To **find** materials on a given topic, by a given author
- To **identify** and confirm that the record retrieved corresponds to the document or format needed
- To **select** based on information to choose which of multiple records best suits the user's needs for language, format, etc.
- To **obtain** have enough info to find on a shelf, to order, a link to access electronically, etc.
- Since first publication of FRBR: to *navigate* (e.g. among records in a database, headings in an index)
- Other suggestions have been: to *manage* and to *preserve*

RDA on the Ground | APLA 2013

entity analysis technique

- identified the **entities** in bibliographic records that would support fundamental user needs
- grouped the entities into 3 groups
- determined basic **relationships** among the entities
- identified the most significant **attributes** of the entities and designated them as **core**

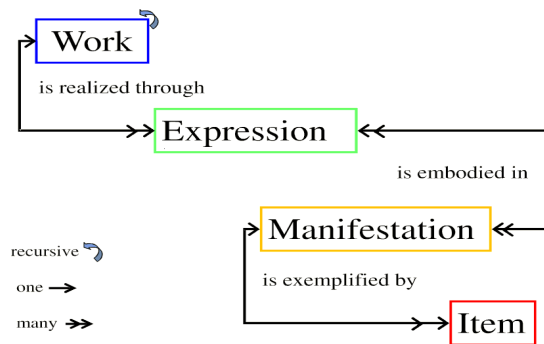


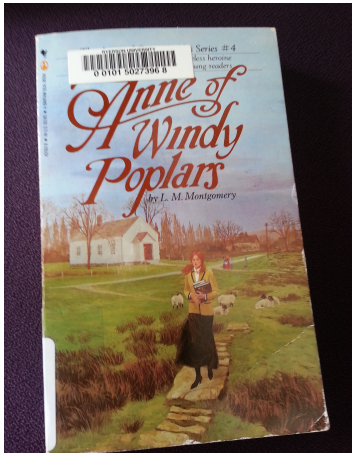

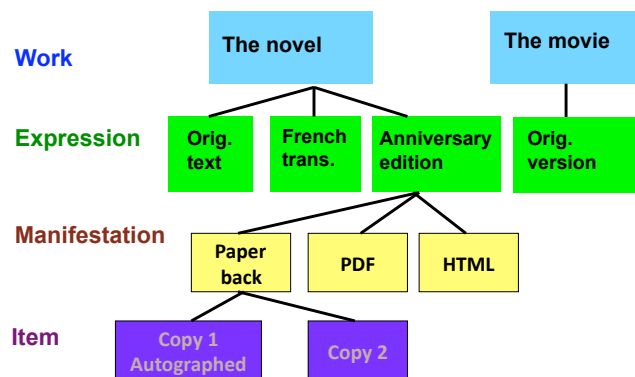

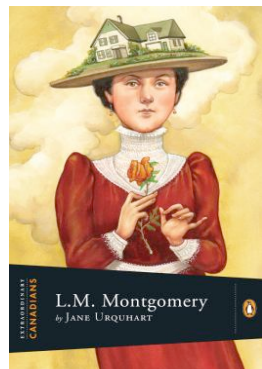
Group 2 entities

- are responsible for the production of or custodianship of group 1 entities

RDA on the Ground | APLA 2013

Group 3 entities

- Concepts
- Objects
- Events
- Places
- plus any entity from group 1 or group 2

Examples of relationships between Group 2 and Group 1 entities

- Authors, artists, composers
 - create *Works*
- Editors, translators
 - “realize” *Expressions*
- Publishers, printers
 - issue or manufacture manifestations
- Donors, libraries
 - own items

Relationships are not just hierarchical

Work to work

- sequels, supplements, chapters within

Expression to expression

- revisions, abridgements, translations

Manifestation to manifestation

- reproductions, simultaneous editions

Item to item

- bound-together copies

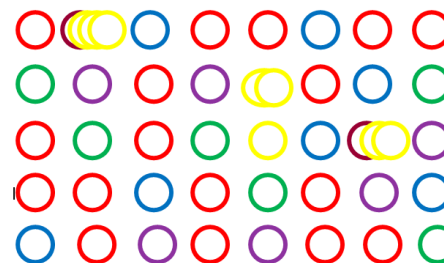

- consists of elements that are used to
find identify select obtain
- find identify clarify understand**
- is accurate & precise & machine-usable

What is the same?

Goals are still to

- describe the resource
- identify those responsible for the work
- make connections to related works

RDA 0.0 purpose & scope

formulating data to support resource discovery

- based on **principles** not rule by example
- designed to assist users with the following tasks
 - find
 - identify
 - select
 - obtain

RDA on the Ground | APLA 2013

RDA principles 0.4.3

Differentiation

The data describing a resource should differentiate that resource from other resources.

Sufficiency

The data describing a resource should be sufficient to meet the needs of the user with respect to selection of an appropriate resource.

Relationships

The data describing a resource should indicate significant relationships between the resource described and other resources.

Representation

The data describing a resource should reflect the resource's representation of itself.

Common Usage or Practice

Data that is not transcribed from the resource itself should reflect common usage in the language and script preferred by the agency creating the data.

RDA structure

Divided according to two goals of resource description

Identify and **Relate**

- No longer organized by class of materials

Each chapter in Section 1 addresses a user task

2/ Identifying Attributes of Manifestations & items

FIND / IDENTIFY

3/ Describing Carriers **SELECT**

4/ Providing Acquisition & Access Information **OBTAIN**

RDA structure

General introduction

Recording attributes

- ch. 1-7: work, expression, manifestation, item
- ch. 8-16: person, family, corporate body, place

Recording relationships: ch. 17-22, 24-32

Appendices

Glossary

RDA structure

RDA is not organized by format OR carrier

Each instruction applies to all types of material, all types of physical formats

- Some guidelines and instructions in chapters refer specifically to resources issued in a particular manner.

RDA on the Ground | APLA 2013

RDA structure

3.4.1.3 Recording Extent

Record the extent of the resource by giving the number of units and an appropriate term for the type of carrier as listed under [3.3.1.3](#)

specific instructions for

- cartographic resources
- notated music
- still images
- text
- three-dimensional forms

RDA on the Ground | APLA 2013

Structure of the description

- AACR2's levels of description have been replaced by a set of required elements
- Core Elements
 - Guided by FRBR/FRAD "high value" elements to support user tasks, ISBD mandatory elements
 - a floor not a ceiling – a place to begin with potential to go further and add as many elements as your situation warrant

Structure of the description

CORE IF statements

- Some elements become Core IF another element is absent
 - Place of distribution **is a core element** for a resource in a published form **if** the place of publication is not identified.

RDA on the Ground | APLA 2013

Exceptions to the rule?

- At certain points you are offered
 - Options for additions or omission
 - Alternatives to the stated rule
- Library of Congress has published their decisions on when their catalogers will apply these alternatives and options

RDA on the Ground | APLA 2013

Alternatives and Options

0.8

Alternative guidelines and instructions provide an alternative to what is specified in the immediately preceding guideline or instruction.

Optional instructions provide for either:

a) the **optional addition** of data that supplement what is called for in the immediately preceding instruction

or

b) the **optional omission** of specific data called for in the immediately preceding instruction.

RDA on the Ground | APLA 2013

Alternatives

At certain points RDA offers an alternative to the stated rule

1.7 When instructions specify transcription ... apply the general guidelines on capitalization, punctuation, symbols, abbreviations

ALTERNATIVE

If the agency creating the data has established in-house guidelines on capitalization, punctuation, symbols, abbreviations, etc. or has designated a published style manual, use those guidelines or that style manual

RDA on the Ground | APLA 2013

Optional provisions

1.4 Language and Script

LC-PCC PS

- Record the elements listed below in the language and script in which they appear on the sources from which they are taken.

Optional Addition

- Record an element listed above in a transliterated form in addition to the form recorded in the script used on the source

LC practice/PCC practice for Optional addition: If non-Latin scripts are provided for the elements listed at [RDA 1.4](#), provide romanized equivalents for those elements listed as "Mandatory if Applicable" in the [PCC Guidelines for Creating Bibliographic Records in Multiple Character Sets](#)

RDA on the Ground | APLA 2013

AACR2 to RDA vocabulary

- First Level of Description → Core Element Set
- Chief Source of Information → Preferred Source
- Physical description → Describe carriers
- Notes on the content → Describe content
- Make added entries → Record relationships

RDA on the Ground | APLA 2013

AACR2 to RDA vocabulary

- heading → authorized access point
- author, composer, etc. → creator
- main entry → Authorized access point for a work (preferred title + authorized access point for creator if appropriate)
- uniform title → (1) preferred title (+ other information to differentiate)
(2) conventional collective title Works

RDA on the Ground | APLA 2013

AACR2 to RDA vocabulary

- GMD → media type
General material designation → carrier type
content type
- Physical description → Carrier description

AACR2 to RDA vocabulary

- see reference → variant access point
- see also reference → authorized access point for related entity

RDA on the Ground | APLA 2013

Elements of the description

RDA 1.4 specifies which elements of the description are

- Transcribed
- Recorded
- Supplied

RDA on the Ground | APLA 2013

Elements of the description

- Transcribed elements
 - Title / Statement of responsibility
 - Edition statement
 - Publication statement (Place, Publisher, Date)
 - Numbering
- Recorded elements
 - Carrier information
 - Physical characteristics
 - Content information

RDA on the Ground | APLA 2013

Elements of the description

Supplied elements

Data about the resource that is gathered from sources outside the resource itself

There are guidelines governing

- supplied titles
- supplied dates

RDA on the Ground | APLA 2013

Representation principle

Take what you see /accept what you find

Do not introduce abbreviation

AACR2 uses abbreviations in certain transcribed elements such as edition, numbering, place of publication

RDA permits abbreviations in transcribed elements **only** if that is how they are represented on the source

Do not correct errors

AACR2 directs that inaccuracies be corrected

RDA requires inaccuracies to be recorded as they appear

No more use of [sic] or [i.e. ____]

RDA on the Ground | APLA 2013

Use of capitalization

1.7.2 Capitalization

Apply the instructions on capitalization given in appendix [A](#)

A.1 General Guideline

Unless there are specific guidelines under [A.2–A.9](#), capitalize words according to the guidelines for the language involved

RDA on the Ground | APLA 2013

Use of abbreviation

B.4 Transcribed Elements

For transcribed elements, use only those abbreviations found in the sources of information for the element

If supplying all or part of a transcribed element, generally do not abbreviate words

RDA on the Ground | APLA 2013

Use of abbreviation

You can adjust what is found on the resource when providing recorded elements

Instructions at **B5** direct you to use prescribed abbreviations in recorded elements for :

dimension

duration

details about musical works

date: use the abbreviations A.D. and B.C. when recording a date in the Christian calendar associated with a person

RDA on the Ground | APLA 2013

AACR2
specifies
chief source of information
for each class of material

RDA specifies *preferred source of information* for three categories :

- one or more pages, leaves, sheets, cards
- moving images
- other resources

2.1.2.2 When preparing a comprehensive description for a resource issued as a single unit choose a source of information identifying the resource as a whole

RDA on the Ground | APLA 2013

RDA

2.2.2 use as the preferred source of information a source forming part of the resource itself that is appropriate to:

- the type of description, and
- the presentation format of the resource

2.2.2.2 use the title page, title sheet, or title card (or image thereof) as the preferred source of information

RDA on the Ground | APLA 2013

AACR2
requires information taken from a source other than the chief source to be enclosed in [square brackets]

RDA
requires [square brackets] **ONLY** when information is from **outside the resource**

RDA on the Ground | APLA 2013

Recording relationships

- Key aspect of FRBR/FRAD model
- Most are beyond CORE elements
- Decide which are important in your environment

Recording Primary Relationships

4 relationships are CORE RDA elements

- Creator
- Other person or corporate body associated
- Work manifested
- Expression manifested

Recording relationships

Recording Relationships Between Works

LC considers two types as CORE

- whole/part for works in a compilation
- Serial relationships earlier/later titles

RDA on the Ground | APLA 2013

RDA and MARC

RDA is independent from any encoding method

HOWEVER

changes to MARC21 have been made to allow us to continue to use MARC until a new encoding standard emerges. This will improve the data structure now in preparation for what the future brings.

RDA on the Ground | APLA 2013

new emphasis: accuracy & precision

truthful representation balanced with accuracy

specify relationships with designators to clarify

record data elements in distinct and labeled
chunks

more controlled vocabulary



RDA on the Ground | APLA 2013

The strongest link: libraries and linked data

- the semantic web relies on highly structured metadata that allow computers to understand the relationships between objects
- the technology is ready; it is now a matter of getting libraries and librarians ready as well

AACR2 vs. RDA terminology

AACR2	RDA
Heading	Authorized access point
Author	Creator
Main entry	Preferred Title or Authorized Access Point for creator + Preferred Title
Uniform title	1. Preferred Title and any differentiating info 2. a conventional collective title, e.g. Works; Symphonies; Poems
See reference	Variant access point
See also reference	Authorized access point for related entity

RDA Name Authority Records

- What can you expect to see now?
- New fields
- 667 note
- Bringing back the 678
- Changes to “old” (familiar!) fields (1XX/4XX/5XX)

RDA on the Ground | APLA 2013

Programmatic Changes to LC/NACO Authority File

- PCC Acceptable Heading Implementation Task Group:
 1. All authority records that cannot be used under RDA are given a note in the 667 field.
 2. All authority records that cannot be used under RDA, but contain an element that can be mechanically changed to make them conform to RDA, are so manipulated.
 3. The remaining records (whose headings appear to conform to RDA without mechanical adjustment) are re-coded as RDA.

667 Note

- “THIS 1XX FIELD CANNOT BE USED UNDER RDA UNTIL THIS RECORD HAS BEEN REVIEWED AND/OR UPDATED”
- “RDA-trained PCC catalogers encountering a name authority record (NAR) with this 667 field should evaluate the 1XX field, and the remainder of the authority record.”

008/10, 040, Subfields \$u and \$v

- 008/10 (Descriptive cataloging rules code)
= “z” (other)
- 040 (Cataloging source)
\$e (Description conventions)
= “rda”
- Most new RDA fields will accept subfields:
 - \$u Uniform Resource Identifier
 - \$v Source of information

- Summary of MUN local policy:
 - Search elsewhere for the established heading/AAP first
 - If you don't find an established heading/AAP, but the name is unique and you have easy access to dates, add the dates.
 - If the name is not unique, add dates (for sure!) if you have them, and/or other information **readily available** to you to distinguish the name. (9.19.1.4-9.19.1.6)
 - Put on Authority Maintenance Shelf

Use also for persons, etc., creating a new work by paraphrasing, rewriting, or adapting works by another creator such that the modification has substantially changed the nature and content of the original or changed the medium of expression.

librettist An author of a libretto of an opera or other stage work, or an oratorio.

lyricist An author of the words of a non-dramatic musical work, except for oratorios.

screenwriter An author of a screenplay, script, or scene.

cartographer A person, family, or corporate body responsible for creating a map, atlas, globe, or other cartographic work.

choreographer A person, family, or corporate body responsible for creating a work of movement.

compiler A person, family, or corporate body responsible for creating a new work (e.g., a bibliography, a directory) through the act of compilation, e.g., selecting, arranging, aggregating, and editing data, information etc. For a compiler as a contributor, see *editor of compilation*, I.3.1 [RDA](#).

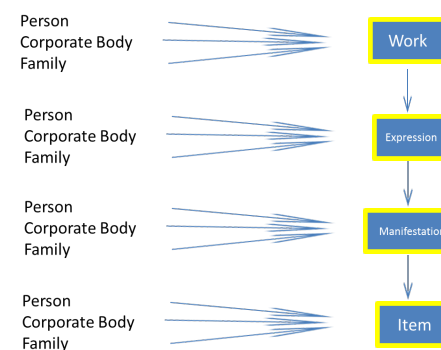

decide how your cataloguers will deal with "options"

determine impact on public display and catalogue functionality (such as exporting to Refworks)

The hybrid environment

- AACR and RDA records residing together in your catalogue
- AACR2 descriptions with RDA access points
 - with relationship designators ... hidden or indexed and displayed
 - with 336-337-338 elements ... hidden and invoked by your ILS to generate meaningful information

do not introduce abbreviations into RDA records
